A Holy Alliance against Nations?**

Two hundred years ago, the crowned heads of Europe came together at the Congress of Vienna. Following the fall of Napoleon the revolutionary genie was finally back in the bottle. The great powers promised to join forces to stamp out any attempt to upset the new order they had sketched out. To that end they established what became known as the "Holy Alliance".

This conservative pact could not however prevent the map of Europe from changing drastically. Empires and federations locked horns and everywhere new nations were born. One hundred years ago, half of today's 28 EU Member States were not yet independent. But that does not stop the current European elite from denouncing anything that threatens the political status quo.

As long as the rumbling was restricted to the former Eastern Bloc, the European leaders didn't lose any sleep over it. Now that the status quo is under threat in their own Union, however, the alarm bells are ringing. Suddenly, after two hundred years, the Holy Alliance is stirring once more.

The Scottish referendum in September already showed the ugly face of that conservative pact.


The Scottish spectre may have been banished for a while, but the Holy Alliance now has an even harder nut to crack: Catalonia and the other Nations in Europe...

Mr Szwabski calls for an 'open door for accession' in next 5 years



During the JCC Montenegro which took place in Kotor on 27 October 2014 Mr Stanisław Szwabski, President of Gdynia Assembly, co-chair of the JCC Montenegro welcomed the progress made by Montenegro during last year. Macroeconomic stability has been broadly maintained and Montenegro continues to sufficiently meet the political criteria for EU membership.

At the same time he is worried that shortcomings with regard to the independence and accountability of the judicial system remain a matter of serious concern and hamper the fight against corruption. The government should continue publicly promoting and supporting media freedom, avoiding any statements that may be understood as intimidation.

"In this context it is difficult for me to agree with the position of the President elect of the EC that our citizens need a pause from enlargement so we can consolidate what has been achieved among the 28 and a freezing of the further enlargement for over the next 5 years. I am convinced that this policy in the long term will have negative results for the EU." – said Mr Szwabski

He highlighted: "I think from the perspective of the LRAs and the citizens we should keep the doors open for candidates countries. If ever one of them is ready to access before the term of 5 years we shouldn't block the opportunity to become a member of our EU family. Saying that, I hope the CoR will have the European Parliament's support in this area/on this issue. I strongly encourage the European Parliament and the Council to see this issue from this perspective." During the December Plenary Session the CoR will adopt the opinion drawn up by Marek Olszewski (PL/EA), Mayor of Lubicz, on Recognition of skills and competences acquired through non-formal and informal learning. The European Commission is expected by next year to revise policy priorities in the framework of the renewed Europe 2020 strategy and on the European Area of skills and competences acquired not only through formal but also non-formal informal learning, while ensuring permeability between different levels of education.

"In my opinion there is a strong need to create pan-European strategy (in the form of guidelines and possible implementation scenarios) for establishment of common framework for recognition and validation of informal and non - formal education / learning in order to facilitate creation of relevant national procedures. Given these trans-national aspects, transnational cooperation structures (both public and private) must also be involved in developing validation procedures. In this opinion I show the necessity to set up common quality standards for the recognition procedures. It would also have great impact on flexibility and mobility as a means of education."- said Mr Olszewski

Buchanan participates in discussions on Albania's progress towards EU accession



On 11 November 2014, the European Alliance group member Cllr Tony Buchanan participated in the CoR Working Group on Western Balkans in Albania's second largest city Durres. The meeting provided an opportunity to discuss the latest developments in the country with regard to the progress towards EU accession and the impact of the enlargement process at local level. Through the accession process, the EU promotes democracy and fundamental freedoms and consolidates the rule of law across the aspirant countries, reducing the impact of cross-border crime. Current enlargement policy is reinforcing peace and stability in the Western Balkans and promoting recovery and reconciliation after the wars of the 1990s. Mr Buchanan said that he is keen to see Albania reach good results in building a stronger democratic political system and in tackling the cultivation and trafficking of drugs as stated in Enlargement Progress Report 2014 for Albania.

"I am happy that the European Council took a decision on June 2014 to grant Albania candidate status. It is recognition for the reform steps undertaken. Albania has made progress over the past year. It is also an encouragement to step up the pace of reforms. But Albania still needs to meet further key priorities, with particular focus on administration reform, the rule of law and fundamental rights. There must also be a strengthened focus on good economic governance. Our mission is to help our colleagues from Albanian LRAs to make face to all these efforts." - he added

At a meeting with the President of the European Council Mr Herman Van Rompuy, European Alliance Group President Dr Uno Silberg called for next week's €300 billion EU investment



The Committee of the Regions and its Rapporteur Cllr. Linda Gillham expressed disappointment as EU Member States and MEPs came to an agreement which would ensure that by 2019 no more than 90 plastic bags per person per year will be used. The Committee – which represents Europe's local and regional authorities - had hoped for an outright ban of free plastic bags by 2020, compulsory EU targets for all Member States and the introduction of charges for all carrier bags to ensure an 80% reduction.

After the new European Commission considered pulling the entire package

package not to focus only on large scale projects but also to examine and promote smaller projects which would make the funds more accessible for local and regional authorities.

Dr Silberg also said that often investments from the private sector are focussed on return on investment and there is a danger that most of the investment would go to centres of population and cities. There needs to be a clear focus on Rural areas and in particular leveraging the financing of CAP Pillar II with loans from the European Investment Bank.

European Alliance Group members have been to the forefront of the CoR political views on investments via the opinion of Witold Krochmal's opinion on ' Long-term financing of the European economy' and Rhodri Glyn Thomas's opinion on: Synergies between private investment and public funding at local and regional levels

Gillham expresses disappointment that the outright ban on Plastic bags has not been fully agreed

to reduce plastic bag usage, speaking on behalf of the Committee Cllr. Linda Gillham said, "There were hopes that governments would use the opportunity to rid Europe of the unnecessary overuse of plastic bags once and for all. But as the European Commission was close to pulling the plug on the entire proposal, we are relieved - as this agreement is better than no agreement. The proposal to cut the average number of lightweight plastic bags each year from 198 to 90 per person by 2019 is a compromise. It is a recognition that the environmental, social and economic consequences of the 100bn tons of plastic bags thrown away each year in Europe are illogical and unacceptable".

TheCommitteeoftheRegionsarguedthat it would have been better to introduce both binding targets and oblige Member States to use economic instruments, such as introducing charges and taxes, rather than giving them the choice between the two options. Cllr Gillham, from UK's Runnymede Council, who was responsible for leading the Committee's position on the issue, also criticised the decision to exclude oxo-biodegradable plastic in the new EU proposals after resistance from the UK government. "Oxo-biodegradable plastic is not fully biodegradable and should be banned. We must remember that it is communities and local authorities that are ultimately responsible for cleaning up the mess. 8% of all throw-away plastic bags end up in our seas: it is our environment and local authority resources that will pay the price for continuing to use plastic that is not 100% biodegradable".
